• NLAO visits web site https://apy.nps-proteantech.in/CRAlite/ and login with user id and password.











NLAO has to visit CRA web site https://apy.nps-proteantech.in/CRAlite/ and login with another user id, password, AADHAR and OTP







- In case of rejection, NLAO has to select reject button and mention the rejection reason.




